Food defense—ideologically motivated intentional adulteration that makes the food injurious to health. Food fraud—economically motivated intentional adulteration that may or may not make the food injurious to health. Thus, some food fraud issues may overlap with the definition of food defense whilst others may be a food quality issue.
